Sub: Closure of Trading Window

Ref: SEBI (Prohibition of Insider Trading) Regulation, 2015

With reference to captioned subject and our earlier communication to stock exchange dated 31st March, 2020, wherein we have informed the closure of trading window from 1st April, 2020 till 48 hours after the declaration of Financial Results for the Quarter and Year ended 31st March, 2020.

In view of the relaxation provided by SEBI for submitting the Financial Results for the Quarter and Year ended 31st March, 2020 till 31st July, 2020, we shall be submitting the said results duly approved by the Board of Directors within the aforesaid extended time and consequently, the trading window would continue to remain closed.

Further, in line with the SEBI (Prohibition of Insider Trading) Regulations, 2015 and Company's Code of Conduct for Prevention of Insider Trading, the trading window is required to be closed from 1st July, 2020 till 48 hours after the declaration of the Financial Results for the Quarter ending 30th June, 2020.

Accordingly, the trading window for dealing in the shares by the Designated Persons of the Company and their immediate relatives, will continue to remain closed till 48 hours after the declaration of Financial Results for the quarter ending 30th June, 2020 and all the Designated Persons of the Company and their immediate relatives have been intimated not to trade in the Company's shares during the aforesaid period of closure of Trading Window.


