5 dead in South Carolina home shooting INMAN (SOUTH CAROLINA): Five people died on Sunday night in a shooting at a home in northern South Carolina, authorities said. Spartanburg County deputies and emergency workers found them suffering from gunshot wounds at a house in Inman, Spartanburg County Coroner Rusty Cleverger said in a statement.

8 people killed in landslide in Nepal KATHMANDU: At least eight people were killed and around 500 families were displaced on Monday when a landslide hit Karnali province's remote Mugu district, local authorities said. Senior police officials said that bodies of eight of the deceased have been recovered from the landslide site situated in Western Nepal.

Paris trial opens over crimes against humanity in Liberia PARIS: A former Liberian rebel went on trial on Monday in Paris on charges of crimes against humanity, torture and acts of barbarism during the West African country's civil war in the 1990s. Kunti Kamara, 47, is notably accused of "complicity in massive and systematic torture and inhumane acts" against the civilian population committed in Liberia's Lofa county in 1993-1994, as one of the leaders of the Ulimo armed group. He was then less than 20 years old. He denied committing such acts. Kamara was arrested near Paris in 2018, following a complaint filed by Swiss-based group Civitas Maxima.
