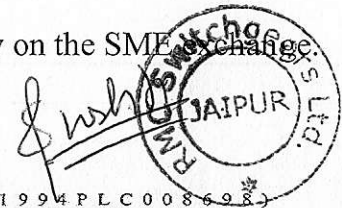

- (b) Companies whose specified securities are listed exclusively on the SME Exchange.
