  - d. Corporate Social Responsibility – Member, Independent Director

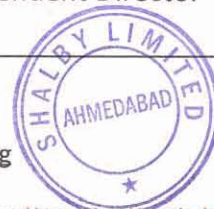

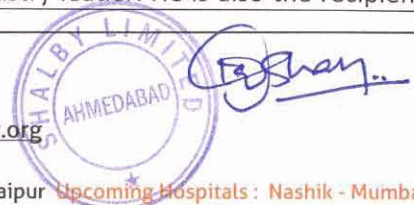


