He further informed that since the meeting is being held electronically, the proxy related procedures have been dispensed with.

All the Board of Directors were present at the e-AGM, including the Chairman of the Audit Committee, Chairman of Nomination and Remuneration Committee, Chairman of Corporate Social Responsibility and Chairman of the Stakeholders Relationship Committee.

Further the Chairman informed that the Members that the statutory registers under the Companies Act 2013 were available to the members for inspection in electronic form.

The Notice dated 12.6.2020 convening the Annual General Meeting was taken as read with the consent of the Members since it was already circulated to them.

- Reappointment of Mr.V.M.Seshadri, Managing Director who retires by totation and being eligible offers himself for reappointment (Ordinary Resolution).

## SPECIAL BUSINESS:

- Approval of remuneration payable to the Cost Auditors for the financial year ending 31.3.2021 (Ordinary Resolution).
- Reappointment of Mrs.Maheshwari Mohan, Independent Woman Director not liable to retirement by rotation and to hold office for the second term of five years from 21.8.2020 (Special Resolution).

Conclusion: The Chairman further informed to the shareholders that Mr.Balu Sridhar from M/s.A.K.Jain Associates Practising Company Secretaries has been appointed as the Scrutinizer for conducting the remote e-voting and e-voting process at the e-AGM.
