Sub: Closure of Trading Window

Ref: SEBI (Prohibition of Insider Trading) Regulation, 2015

With reference to captioned subject and our earlier communication to stock exchange dated 31st March, 2021, wherein we have informed the closure of trading window from 1st April, 2021 till 48 hours after the declaration of Financial Results for the Quarter and Year ended 31st March, 2021.

As the declaration of Financial Results for the Quarter and Year ended 31st March, 2021 is yet to be made owing to the delay in finalizing the accounts on account of various challenges being faced due to the pandemic situation, the trading window would continue to remain closed.

Further, in respect of the Quarter ended 30th June, 2021, in line with the SEBI (Prohibition of Insider Trading) Regulations, 2015 and Company's Code of Conduct for Prevention of Insider Trading, the trading window is required to be closed from 1st July, 2021 till 48 hours after the declaration of the Financial Results for the Quarter ending 30th June, 2021.

Accordingly, the trading window for dealing in the shares by the Designated Persons of the Company and their immediate relatives, will continue to remain closed till 48 hours after the declaration of Financial Results for the quarter ending 30th June, 2021 and all the Designated Persons of the Company and their immediate relatives have been intimated not to trade in the Company's shares during the aforesaid period of closure of Trading Window.

The date of the Board Meeting for consideration of the Financial Results would be intimated in due course.
