As your good self is already aware that the Jet Airways (I) Limited ("Company") was undergoing Corporate Insolvency Resolution Process (CIRP) and the Resolution Plan submitted by the consortium of Mr. Murari Lal Jalan and Mr. Florian Fritsch was approved by the Adjudicating authority (intimation was given vide letter dated June 22, 2021 about the approval of the Resolution plan by the Adjudicating Authority (National Company Law Tribunal, Mumbai) and receipt of detailed order dated June 30, 2021).
