- A. We, S. Krishnamurthy & Co., Company Secretaries, have examined:
- (a) all the documents and records made available to us and explanation/representation provided by **Ramco Industries Limited** ("the listed entity"),
- (b) the filings/ submissions made by the listed entity to the National Stock Exchange of India Limited (NSE) and BSE Limited (BSE), where its equity shares are listed ("the stock exchanges"),
- (c) website of the listed entity; and
- (d) other relevant documents/filings which have been relied upon to make this certification,

for the year ended 31st March 2019 ("Review Period") in respect of compliance with the provisions of:

- (a) the Securities and Exchange Board of India Act, 1992 ("SEBI Act") and the Regulations, circulars, guidelines issued thereunder; and
- (b) the Securities Contracts (Regulation) Act, 1956 ("SCRA"), rules made thereunder and the Regulations, circulars, guidelines issued thereunder by the Securities and Exchange Board of India ("SEBI");
- B. The **Specific Regulations**, whose provisions and the circulars/ guidelines issued thereunder, have been examined, are:
- (a) Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR");
- (b) Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("SAST");
- (c) Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 ("PIT"); and
- (d) Other regulations applicable:
  - (i) The Securities and Exchange Board of India (Depositories and Participants) Regulations, 1996, replaced by The Securities and Exchange Board of India (Depositories and Participants) Regulations, 2018 ("DP") (with effect from 3<sup>rd</sup> October 2018).

- C. Based on the above examination and the information, explanation and representations provided to us by the listed entity, its officers, agents and authorised representatives during such examination, we hereby report that, during the Review Period:
  - (a) The listed entity has generally complied with the provisions of the above Regulations and circulars/guidelines issued thereunder. However, we note the following as regards compliance with Regulation 33(1)(d) of LODR.
    - (i) The listed entity is required to ensure that the limited review reports submitted to the stock exchanges on a quarterly basis are to be given only by an Auditor who has subjected himself to peer review process of the Institute of Chartered Accountants of India (ICAI) and holds a valid certificate issued by the Peer Review Board of ICAI.
    - (ii) The Peer Review process of one of the Company's Joint Auditors M/s. Ramakrishna Raja & Co., was due for review on 15th August 2018.
    - (iii)The process was initiated before the said date. The final report was sent to the Peer Review Board by the Peer Reviewer on 15th November 2018 and the Certificate was issued by the Peer Review Board on 26th March 2019.
- (b) The listed entity has maintained records under the provisions of the above Regulations and circulars/ guidelines issued thereunder in so far as it appears from our examination of those records.
- (c) No action has been taken against the listed entity/its promoters/directors/ subsidiaries either by SEBI or by Stock Exchanges (including under the Standard Operating Procedures issued by SEBI through various circulars) under the aforesaid Acts/ Regulations and circulars/ guidelines issued thereunder.
- (d) This report being the first report under Regulation 24A of LODR, the requirement to take any actions to comply with the observations made in previous reports did not arise.
- (e) The following SEBI Regulations were not applicable to the Listed entity during the Review Period:
