Dear Sir/ Madam,

As per the captioned Regulation read with SEBI Circular No. SEBI/HO/CFD/CMDI/P/CIR/2021/556 dated April 29, 2021, Jhandewalas Foods Limited ("the Company") is required to submit its audited financial results as on 31st March, 2021 ("the Results") to the stock exchanges by 30th June, 2021.

The Company had in view of the following reasons, anticipated that the completion of the Results would not be completed within the time frame and request you to grant of time till 31st August, 2021 to comply with the requirement of submission of the Results to the stock exchanges:

- Following the outbreak of second wave of Covid - 19 pandemic that has proved to be way too challenging and dangerous, state wide lock down was imposed by the Government of Rajasthan w.e.f 19th April 2021 and subsequent lockdowns were imposed from May 10th to June 9th 2021, consequent where to the Company's operations were temporarily suspended since 19th April 2021. During lockdown movement of people were restricted as per guidelines issued by Government of Rajasthan. Most of the commercial and private establishment were closed and only works from home were allowed.

2. The gradual resumption of operations and limited functioning of the offices of the Company started from 05<sup>th</sup> June 2021, however restriction still persisted. Therefore, we were forced to continue with very limited access of working staff and working hours in the office.
3. In view of the aforesaid force majeure condition prevailing, the day to day activities and normal operations of the Company to the extent of normal business has been affected. In spite of all possible efforts, the Company has been unable to get the audit done for the purpose of preparation of financial statements for the year ended 31<sup>st</sup> March, 2021.

In view of the severity of the force majeure situation explained above, as well as the current situation and hardship being faced by the Company when the impact of pandemic has further intensified, in spite of all possible efforts, the Company has been unable to get the audit done for the purpose of preparation of financial statements for the year ended 31<sup>st</sup> March, 2021.


