Following the outbreak of second wave of Covid - 19 pandemic that has proved to be way too challenging and dangerous, state wide lock down was imposed by the Government of Rajasthan we.f. 19th April 2021 and subsequent lockdowns were imposed from May 10.11 to June gth 2021, consequent whereto the Company's operations were temporarily suspended since 19th April 2021. During lockdown movement of people were restricted as per guidelines issued by Government of Rajasthan. Most of the commercial and private establishment were closed and only works from home were allowed.

- 2. The gradual resumption of operations and limited functioning of the offices of the Company started from os" June 2021, however restriction still persisted. Therefore, we were forced to continue with very limited access of working staff and working hours in the office.

In view of the severity of the force majeure situation explained above, as well as the current situation and hardship being faced by the Company when the impact of pandemic has further int.e~ ifi.~d, ~IP. wis.h m infnrm.znu that the necessarion of the 8esul.t~ has not been corooleted despite the Company taking adequate steps within its contrat.

Hence, vie request you to please take the reason disclosed herein on record and condone the delay and that you are kindly requested not to take any action against the Company for delay in filing the Audited Financial Statements and grant us time till 31st August, 2011 to comply with the requirement of submission of audited financial statements as on 31st March, 2021 to the stock exchanges,

We would like to state that the Company has always been meticulous in complying with the SEBI Regulations/ Companies Act, etc., but the submission of the Results is getting delayed due to unavoidable force-maje ure circumstances.
