Reason for change viz. appointment, resignation, removal, death or otherwise	Mr Naresh Gujral (Mr Gujral) [DIN: 00028444] aged 74 years, Non-Executive Independent Director of the Company was appointed as an Independent Director for a second term of 5 (five) years by the Members of the Company as an Independent Director. His tenure will expire on 19th August, 2024.
	Mr Gujral will attain the age of 75 (seventy five) years on 19 th May, 2023. Upon recommendation of the Compensation and Nomination and Remuneration Committee and approval of the Board of Directors it is proposed that a Special Resolution be passed by the Members of the Company at the ensuing 98 th Annual General Meeting, so that Mr Gujral can continue as a Non-Executive Independent Director even upon attaining the age of 75 (seventy five) years up to 19 th August, 2024.
