ITEM NOS. 1 & 2

Presently the Authorised Share Capital of the Company stands at Rs. 12,50,00,000/- divided into 6,25,00,000 (Six Crore Twenty-Five Lakhs) Number of equity shares of Rs. 2/- each.

The Board of Directors of the Company at its meeting held on 17th February, 2023 decided to increase the Authorized Capital of the Company from 12,50,00,000/- divided into 6,25,00,000 Number of equity shares of Rs. 2/- each to Rs. 50,00,00,000/- divided into 25,00,00,000 Number of Equity Shares of Face Value Rs. 2/- each.
