#Rs. 3 crore was transferred to Ento Proteins Limited out of which 2.658 crore was utilized and the balance Rs. 0.342 crore is lying in Ento Proteins Limited's HDFC Bank Account-7911.

**The estimated IPO expenses were Rs. 38.192 crores, while the actual IPO expenses amounted to Rs. 45.62 crores. The variance between estimated and actual expenses has been absorbed into general corporate purposes.*

The estimated GCP utilization was capped at Rs. 50.910 crore in the last quarter due to excess issuer related expenses of Rs. 4.898 crores. However, in the current quarter the overall variance in IPO expenses of Rs. 7.428 crore including Rs. 2.53 of issue related expenditure incurred in Q1 2025 has been absorbed into general corporate purpose.

- (b) Deviation in the amount of funds actually utilized as against what was originally disclosed or
