Sub: Sub: Intimations under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of SEBI Listing Regulations, 2015, we hereby submit following intimations:

1. Construction of additional factory shed:

The Company is in the process of constructing a new shed in the available space at its Sinnar plant at Nasik, Maharashtra.

The proposed construction of shed is to optimise the use of the available space at the said plant. At present, the use of proposed shed is intended for raw material storage, storage of finished goods, small sub-assemblies and activities like painting, testing and packing. Subsequently, the shed may be used for manufacturing of products also.

The details required to be furnished pursuant to Regulation 30 are as following:
