**Sub: Disclosure under the Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 regarding further development in ongoing litigations/ disputes matters**

Dear Sir/Madam,

In furtherance to our earlier disclosures made on August 14, 2023 and September 04, 2023, regarding disclosure for pendency of litigation(s) or dispute(s), we hereby inform about the further development in HSIIDC execution petition filed before the Rewari District Court by the Company as per the Hon'ble High Court of Punjab and Haryana.

In the said matter the company had withdrawn the matter and received the net payment of Rs. 16.39 Cr. (excluding TDS amount) on 13.10.2023, however as per legal opinion sought by the Company it is found that HSIIDC has made wrong calculations and thus there is a dispute on the compensation amount to be paid as per the Hon'ble High Court of Punjab and Haryana. Therefore, after withdrawn of the said execution petition, the Company has filed a separate execution petition for disbursement of balance compensation amount based on the correct calculations on 24.11.2023 before Rewari District Court. Additionally at this stage; the quantum of monetary impact cannot be quantified as the same is dependent on the decision of the Rewari District Court.

Further the company has also filed an execution petition before the Rewari District Court for execution of the judgment of Hon'ble Supreme Court dated 23.08.2023. In this matter also, the quantum of monetary impact cannot be quantified as the same is dependent on various external factors such time within which the amount will be deposited, factors considered in calculations of compensations etc.

That the intimation was not submitted within the prescribed time limit due to mistake without any malafide intention and in future we shall obliged the time limits of the disclosures prescribed under the SEBI (LODR) Regulations, 2015 and therefore you are requested to condone the delay in filing the above intimation.

Please note that our above-mentioned continual disclosure is in terms of and in compliance with the SEBI (LODR) Regulations, 2015 and circulars thereon. Kindly take the above on your record.
