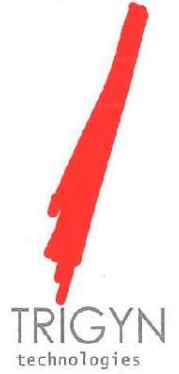

December 31, 2020

Mumbai – February 09, 2021

Trigyn Technologies Limited for the nine months ended on December 31, 2020 on consolidated basis has achieved growth of **7.7 %** with revenue from operations of **Rs. 72,710.19 Lakhs in FY-21** as against **Rs. 67,494.31 Lakhs in FY-20**. The growth was recorded in Earnings After Tax for the same period which is **Rs. 4,975.82 Lakhs** as against **Rs. 4,685.57 Lakhs** in the previous year's corresponding period.

With respect to the nine months ended on December 31, 2020 on standalone basis, Company has achieved growth of **2 %** with revenue from operations of **Rs. 5,695.34 Lakhs in FY-21** as against **Rs. 5,572.68 Lakhs in FY-20** in the previous year's corresponding period. The Earnings After Tax for the same period is **Rs. (107.34) Lakhs** as against **Rs. 445.10 Lakhs** in the previous year's corresponding period.
