घरेलू मूल उपकरण विनिर्माताओं, नए कलपुर्जी और निर्यात की कमजोर मांग के कारण वाहन कल पुर्जा क्षेत्र का राजस्व 2020-21 में 14 से 18 फीसद तक घट सकता है। रेटिंग एजंसी इक्रा ने यह अनुमान व्यक्त किया है।

कोरोना महामारी तथा इसकी रोकथाम के लिए देश भर में लागू की गई पूर्णबंदी से वाहन कल पुर्जा उद्योग बुरी तरह से प्रभावित हुआ है। हॉलांकि, बैटरी व टायर जैसे उद्योगों पर असर कम रहेगा। इक्रा ने एक बयान में कहा कि वित्त वर्ष 2020-21 में वाहनों की बिक्री में करीब 15-16 फीसद की गिराबट रहने के अनुमान हैं। इनमें से यात्री वाहन श्रेणी में गिरावट 22 से 25 फीसद तक की रह सकती है।
