

# Sona BLW Precision Forgings Ltd. announces Q2 FY22 Results

Revenue grows 52% YoY to Rs. 586 crore, BEV Revenue grows 143% YoY to 22% of total,
EBITDA higher by 24% YoY to Rs. 154 crore, EBITDA Margin at 26.4%
PAT higher by 22% YoY to Rs. 88 crore, PAT Margin at 15.1%, Annualised H1 FY22 RoCE of 34.7%

**Gurugram, India, October 27th, 2021:** Sona BLW Precision Forgings Ltd. (**Sona Comstar**), a leading automotive technology company providing mission critical systems and components for electrified and non-electrified powertrain segments, today announced its financial results for the quarter and half year ended September 30th, 2021.

## Key Financial Highlights – Q2 FY22

- Revenue of Rs. 586 crore with 52% YoY growth; 22% revenue share from BEV; BEV revenue growth of 143% YoY
- EBITDA of Rs. 154 crore with 24% YoY growth; EBITDA margin of 26.4%
- PAT of Rs. 88 crore with 22% YoY growth; PAT margin of 15.1%
- The net order book\* stands at Rs. 13,600 crore as of September 30th, 2021
- H1FY22 YoY revenue, EBITDA and PAT growth of 102%, 90% and 136% respectively

### **Management Comment**

Commenting on the performance, **Mr. Vivek Vikram Singh**, **MD & Group CEO**, said: "This was our best quarter yet. Revenue growth of 52% y-o-y in the second quarter has been driven by rapid scale up of revenues from BEV, which are higher by 143% y-o-y, and now represent 22% of overall revenues. Our profitability and return ratios remain strong, despite the impact of sharply rising input prices. With 3 new BEV programs awarded during the quarter, our net order book stands at Rs. 13,600 crore of which 58.5% is contributed by EV."

### Operational Highlights – Q2 FY22

### **Electrification:**

- **BEV Revenue Share:** Revenue from Battery EV was Rs. 124 crore and contributed 22% of total revenue as against 13.8% in FY21.
- **EV programs:** The number of awarded programs increased from 17 to 20 across 11 different customers.

### **Increasing Global Market Share:**

- Differential Gears: Global market share increased to 6.4% in 9M CY21 from 5.0% in CY20.
- Starter Motors: Global market share in light vehicles increased to 5.0% in 9M CY21 from 3.0% in CY20.

### **Product Diversification:**

• Our journey from components to sub-systems and systems continues to progress, as revenue share of differential assemblies increased from 18% in FY21 to 24% in H1 FY22.

### **Key Developments:**

- Latest order wins expand the addressable market to the entire passenger car space, including the small and mid-segment BEVs, also expanding market reach.
