सरकार ने बुधवार को यूट्यूब पर विभिन्न पहलों व योजनाओं के बारे में झुठे, सनसनीखेज दावों और फर्जी खबरें फैलाने के लिए तीन चैनलों पर रोक लगाने के लिए कहा है। पत्र सूचना कार्यालय की 'फैक्ट चेक' इकाई ने मंगलवार को तीन चैनलों को फर्जी खबरें फैलाने वाला घोषित किया था।

एक आधिकारिक सूत्र ने बुधवार को कहा कि सूचना एवं प्रसारण मंत्रालय ने युट्यूब को तीन चैनलों 'आज तक लाइव', 'न्यूज हेडलाइंस' और 'सरकारी अपडेट्स' को हटाने का निर्देश दिया है।

सरकार ने स्पष्ट किया है कि आज तक लाइव 'इंडिया टुडे ग्रुप' से जुड़ा हुआ नहीं है। एक आधिकारिक बयान में मंगलवार को कहा गया था कि ये चैनल दर्शकों को गुमराह करने के लिए टीवी समाचार चैनलों और उनके प्रस्तोताओं की तस्वीरों का इस्तेमाल कर रहे हैं ताकि यह यकीन दिलाया जाए कि उनके द्वारा साझा की गई खबरें प्रामाणिक हैं। उसने कहा था कि ये चैनल अपने वीडियो में विज्ञापन दिखाते और यूट्यूब पर भ्रामक सूचनाओं से वित्तीय लाभ हासिल करते भी पाए गए।

'फैक्ट चेक' इकाई ने कहा कि युट्यूब पर ये तीन चैनल भारत के उच्चतम न्यायालय, भारत के प्रधान न्यायाधीश, सरकारी योजनाओं, इलेक्टानिक वोटिंग मशीन (ईवीएम) और कृषि ऋगों को माफ करने आदि के बारे में झूठी और सनसनीखेज खबरें फैलाते हैं। उन्होंने यह भी दावे किए कि सरकार उन लोगों को पैसे दे रही है, जिन्होंने बैंक खाते खुलवाए, आधार कार्ड और पैन कार्ड बनवाए हैं। इन यूट्यूब चैनलों के लंगभग 33 लाख 'सब्सक्राइबर' हैं और इनके वीडियो की 30 करोड़ से अधिक बार देखा गया है।

देशमुख के जमानत आदेश पर 27 दिसंबर तक रोक

मुंबई, 21 दिसंबर (भाषा)।

बंबई उच्च न्यायालय ने बुधवार को भ्रष्टाचार के एक मामले में महाराष्ट्र के पूर्व गृह मंत्री अनिल देशमुख को जमानत देने संबंधी अपने आदेश पर रोक की अवधि 27 दिसंबर तक बढ़ा दी। केंद्रीय अन्वेषण ब्यरो (सीबीआइ) इस मामले की जांच कर रहा है। न्यायमर्ति एमएस कार्णिक की एकल पीठ ने 12 दिसंबर को राष्ट्रवादी कांग्रेस पार्टी (राकांपा) के 73 वर्षीय नेता देशमुख को भ्रष्टाचार के मामले में जमानत दे दी थी लेकिन कहा था यह आँदेश 10 दिनों के बाद प्रभावी होगा, क्योंकि सीबीआइ ने इसे शीर्ष अदालत में चुनौती देने के लिए समय मांगा था। जांच एजंसी ने शुक्रवार को उच्चतम न्यायालय का दरवाजा खटखटाया था लेकिन याचिका पर छुट्टियों के बाद जनवरी 2023 में ही सुनवाई होगी।

शिवसेना के पूर्व सांसद के खिलाफ मामला दर्ज

मुंबई, 21 दिसंबर (भाषा)।

मुंबई पुलिस ने शिवसेना के पूर्व सांसद आनंदराव अडसुल और उनके तीन साथियों के खिलाफ एक सरकारी अधिकारी से कथित तौर पर मारपीट करने के लिए गैर-संज्ञेय अपराध दर्ज किया है। एक पुलिस अधिकारी ने बुधवार को बताया कि अभी तक कोई प्राथमिकी दर्ज नहीं की गई है और मामले की जांच की जा रही है। गैर-संज्ञेय अपराध के मामले में पुलिस बिना किसी वारंट के आरोपी को गिरफ्तार नहीं कर सकती और अदालत की अनुमति के बिना जांच शुरू नहीं कर सकती। 'महाराष्ट्रं मंत्रालय को-आपरेटिव क्रेडिट सोसायटी' के उपाध्यक्ष महबूब खान पठान ने आरोप लगाया कि अडसुल अपने तीन साथियों के साथ मंगलवार दोपहर को उनके कार्यालय पहुंचे थे और क्रेडिट सोसायटी के बोर्ड में निदेशकों के तौर पर दो लोगों की नियुक्ति करने के लिए कहा था। शिकायतकर्ता ने कहा कि उन्होंने पूर्व सांसद को छह महीने इंतजार करने को कहा।
