Amid sagging relations between India and China because of bloody skirmishes in Galwan valley, a Chinese firm has reportedly sacked 62 workers from its operation site at Manganese Ore India Limited (MOIL) in Balaghat district of Madhya Pradesh.

The labourers who were working at Bharweli site in Balaghat allege the Chinese firm has refused to take in Indian labourers after lockdown saying they were corona infected.

The memorandum submitted by the workers states they were mocked at by the company officials and asked to approach PM Modi in this

'About 62 labourers were

working with China Coal CC 3 firm. All work stopped at that mine during lockdown. After lockdown, when we went there to join, the Chinese authorities didn't allow us to work," said, Sitesh Katothe, a worker who has been told to quit.

Katothe along with coworkers submitted a memorandum at collector's office in Balaghat against Chinese firm on Friday. He said when they asked the company officials about joining duty, the latter replied they had orders from "above" not to keep any Indian labourer. About 30 Chinese workers are still engaged at the same site.

According to Sitesh's coworkers, work was stopped at MOIL mines on March 24 due COVID-19 lockdown. The management resumed work



Airport-like boarding passes for entry to railway station, trains in UP's Prayagraj

Central Railway has introduced airport like boarding facility at Prayagraj Railway station in order to implement contactless ticket checking, a senior Railway official said on Friday.

Ajit Kumar Singh, CPRO, North Central Railway, passengers arriving at junction station are first taken to a boarding hall with four new check-in counters. These counters are fully contactless keeping in view the safety of our esteemed passengers due to Covid crisis. For scanning ticket and passenger identity particulars, a webcam on the passenger side has been provided which is connected to computer available with ticket checking staff. For communication between passenger and ticket checking staff microphone and speakers are provided on both sides physically separated through glass partition wall of



Assam: Covid-19 patient dies from head injuries while trying to flee quarantine

New delhi: A man (40) has died in Assam due to head injuries sustained while trying to flee from a quarantine centre after he came to know that he has tested coronavirus disease (Covid-19) positive.

The deceased, who had recently returned from Odisha, where he was working, amid the easing of nationwide lockdown restrictions, was quarantined at a makeshift facility in a school near his native village in Bongaigaon district. "The deceased and another person tested Covid-19 positive on Tuesday. He was informed about it and an ambulance was sent to transfer both



tal," said MS Lakshmi Priva, deputy commission-

er (DC), Bongaigaon. "When the ambulance reached the quarantine centre, the other person boarded the vehicle. But the man, who had recently returned from Odisha, gave an excuse that he would need to collect some of his stuff from the quarantine centre. He tried to scale a wall of the centre in a bid

to escape. Unfortunately, he slipped and sustained severe head injuries," the DC added.

He was immediately shifted to the medical college hospital in neighbouring Barpeta district, where he was admitted to the intensive care unit (ICU). He died on Thursday. "Even though he had tested Covid-19 positive, he didn't die due to symptoms related to the viral outbreak. His death won't be counted as a Covid-19 fatality," the DC said. "This is an unfortunate incident and the deceased would definitely have recovered from the viral disease within a few days.

We've no idea why he took such an extreme step. We're taking extra care of all those who are under institutional quarantine in the district," she added.

His last rites were performed at his native village in Bongaigaon district on Thursday, as per the central government's strict guidelines of disposing of bodies of Covid-19 patients. Bongaigaon district has recorded 65 Covid-19 positive cases until Thursday. Around 7,000 people working in other states have returned to the district in the past 45 days since the ban on inter-state movement was

Delhi-NCR: Small magnitude earthquakes do not indicate a bigger one is coming, says Wadia Institute

New delhi: Small magnitude earthquakes in Delhi-NCR region do not indicate a bigger temblor is coming, the Wadia Institute of Himalayan Geology said on Friday.

The Dehradun-based autonomous research institute under the Union science and technology ministry clarified that the vulnerability of a region can be understood from past seismicity, calculation of strain and mapping of active faults. Delhi-NCR is in the second highest seismic hazard zone or Zone IV.

Sometimes a vulnerable remains quiet, experiences small magnitude earthquakes that do not



earthquake, or can receive a sudden jolt by a big earthquake without any call, the institute said in a statement. HT had reported on June 4 that Delhi-NCR

earthquakes in around two months (March 24 to June 3). A 3- magnitude earthquake was recorded near Gautam Budh Nagar on Wednesday night, according to data from the National Center for Seismology. All earthquakes in the past

two months have been mild with only two above 3.5 magnitude. On May 29, Rohtak recorded earthquake of 4.6 magnitude. There have been several more mild quakes in June. The statement from Wadia Institute said: "The recent events cannot be defined as the 'foreshocks'.

If a big earthquake takes place in a region, all smaller events that occurred in the immediate past at that region are categorised as the foreshocks.

LAC to get body protection suits, batons



New delhi: The Indian Army has ordered body protective suits and batons for forward troops deployed along the Line of Actual Control (LAC) in eastern Ladakh, the focus of current tensions with China, to protect them from assaults by Chinese troops, two officers familiar with the development said on Friday.

The Chinese troops have been using stones, iron rods and nail-studded clubs to inflict serious injuries during border brawls. Twenty Indian soldiers, including a colonel, were killed in a seven-hour brawl in Galwan Valley on Monday night. The order for the suits essentially light-weight riot
