These financial statements and other financial information have been audited by other auditors whose report has been furnished to us, and our opinion on the Statements, in so far as it relates to the amounts and disclosures included in the statements is based solely on the report of such other auditors and the procedures performed by us as stated under Auditor`s Responsibilities section above.

Our report on the statement is not modified in respect of the above matters

With respect to our reliance on the work done and reports of the other auditors and financial statements certified by the Management.



- Attention is drawn to the fact that the figures for the quarter ended 31st March 2020 and the corresponding quarter ended in the previous year, as reported in these consolidated financial results, are the balancing figures between audited figures in respect of the full financial year and the published year to date figures up to the end of third quarter of the relevant financial year. Also, the figures up to the end of the third quarter had been reviewed and not subjected to audit. Our report is not modified in respect of this matter.

The Board of Directors of the Company are also responsible of overseeing the financial reporting process of the Company.

Other Matters

- Attention is drawn to the fact that the figures for the quarter ended 31st March 2020 and the corresponding quarter ended in the previous year, as reported in these Standalone financial results, are the balancing figures between audited figures in respect of the full financial year and the published year to date figures up to the end of third quarter of the relevant financial year. Also, the figures up to the end of the third quarter had been reviewed and not subjected to audit. Our report is not modified in respect of this matter.
