We believe that the audit evidence obtained by us and other auditors in terms of their report referred in "Other Matter "section below, is sufficient and appropriate to provide a basis for our opinion.

4) Management's Responsibilities for the Consolidated Financial Results -The Statement has been prepared on the basis of the consolidated annual financial statements. The Holding Company's Board of Directors are responsible for the preparation and presentation of the statement that give a true and fair of the net profit and other comprehensive income and other financial information of the Group in accordance with the applicable Indian Accounting Standards (IND AS) prescribed under Section 133 of the Companies Act, 2013 (The 'Act'), read with relevant rules issued there under, and other accounting principles generally accepted in India and in compliance with Regulation 33 of the listing Regulations. The respective Board of Directors of the Companies included in the Group are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Group for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and the design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the respective financial results that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the consolidated Financial Results by the Directors of the Holding Company, as aforesaid.

If we conclude that a material uncertainty exits, we are required to draw attention in our auditors 's report to the related disclosures in the statement or, if such disclosures are inadequate, to modify our opinion. We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Other Matters

We did not audit the financial statements of 15 subsidiaries included in the consolidated financial statements, whose financial statements reflect total assets of ₹ 6572.48 lacs as at 31 March, 2020; as well as the total revenues of ₹1593.66 lacs and net profit after tax ₹ 18.21 lacs as at 31 March, 2020. These financial statements and other financial information have been audited by other auditors whose report has been furnished to us, and our opinion on the Statements, in so far as it relates to the amounts and disclosures included in the statements is based solely on the report of such other auditors and the procedures performed by us as stated under Auditor's Responsibilities section above.

Our report on the statement is not modified in respect of the above matters With respect to our reliance on the work done and reports of the other auditors and financial statements certified by the Management.



 Attention is drawn to the fact that the figures for the quarter ended 31st March 2020 and the corresponding quarter ended in the previous year, as reported in these consolidated financial results, are the balancing figures between audited figures in respect of the full financial year and the published year to date figures up to the end of third quarter of the relevant financial year. Also, the figures up to the end of the third quarter had been reviewed and not subjected to audit. Our report is not modified in respect of this matter.

In preparing the Standalone financial results, the Board of Directors are responsible for assessing the ability of the Company to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to ease operations, or has no realistic alternative but to do so.

The Board of Directors of the Company are also responsible of overseeing the financial reporting process of the Company.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.

- Obtain sufficient appropriate audit evidence regarding the financial results of the entities within the Group to express an opinion on the statement. We are responsible for direction, supervision and performance of the audit of financial information of such entities included in the statement of which we are the independent auditors.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal controls that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Other Matters

 Attention is drawn to the fact that the figures for the quarter ended 31st March 2020 and the corresponding quarter ended in the previous year, as reported in these Standalone financial results, are the balancing figures between audited figures in respect of the full financial year and the published year to date figures up to the end of third quarter of the relevant financial year. Also, the figures up to the end of the third quarter had been reviewed and not subjected to audit. Our report is not modified in respect of this matter.
