Report on Financial Statements:

1. We have audited the accompanying Financial Statements of "SANGLI SAHAKARI BANK LIMITED", Mumbai as at 31 March 2021, which comprise the Balance Sheet as at 31st March 2021 and Profit and Loss Account, and the Cash Flow Statement for the year then ended and a summary of significant accounting policies and other explanatory nformation. The returns of Head office and its department audited by us and the returns of all 5 branches audited by internal/concurrent auditors of the respective branches are consolidated in these financial statements Key operations of the Bank are automated. With the key applications largely integrated to the core banking systems it does not require it's branches to submit any financial returns. Accordingly, our audit is carried out centrally at the Head Office based on the necessary records and data required for the purposes of the audit being made available to us.

Management's Responsibility for the Financial Statements: 2. Management is responsible for the preparation of these Financia Statements that give true and fair view of the financial position and financial performance and cash flow of the Bank in accordance with the Banking Regulation Act, 1949 (as applicable to Co-operative Societies) the guidelines issued by the Reserve Bank of India and the Registrar of Co-operative Societies, Maharashtra, the Maharashtra Co-operative Societies Act, 1960, and the Maharashtra Co-operative Societies Rules, 1961, (as applicable) and generally accepted accounting principles in India so far as applicable to the Bank. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation of the financial statements that are free from material

misstatement, whether due to fraud or error. **Auditors' Responsibility:**

3. Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our Audit opinion.

6. Other matters

In view of the Government imposed lockdown and travel restrictions as a result of continuous spreading of COVID19 across India, we were unable $\,$ to physically visit some branches and certain aspects of the year-end statutory audit have been carried out based on remote access of certain data which has been represented, for our audit purposes, as correct complete, reliable and directly generated by the accounting system of the bank without any manual modifications.

Under the aforesaid circumstances, our audit has duly considered the advisory on "Specific Considerations while conducting Distance Audit Remote Audit / Online Audit of Bank under current, Covid-19 situation' issued by the Auditing and Assurance Standards Board of ICAI. We have also relied on alternative audit procedures as per the SAs to obtain reasonable assurance whether the Financial Statements, as a whole, are free from material misstatement, whether due to fraud or error. Opinion:
7. In our opinion and to the best of our information and according

to the explanation given to us, subject to our observations in Audit Memorandum, the aforesaid financial statements together with the Notes thereon give the information required by the Banking Regulation Act. 1949 (as applicable to co-operative societies), the Maharashtra Co-operative Societies Act, 1960, the Maharashtra Co-operative Societies Rules 1961 and guidelines issued by Reserve Bank of India and Registral of Co-operative societies, Maharashtra in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, subject to the qualification in clause (b) as mentioned in below:

(a)In the case of the Balance Sheet, of the state of affairs of the Bank as at 31st March 2021:

(b) In the case of the Profit and Loss Account, bank has reported loss for the year ended on that date of Rs. 253.35 lakh. However there is an understatement of loss to the bank of Rs.1,135.43 lakh which

within the powers of the Bank; d) The Balance Sheet and the Profit and Loss Account dealt with by this report, are in agreement with the books of account and

e) The accounting standards adopted by the Bank are consistent with those laid down by accounting principles generally accepted in India so far as applicable to Banks subject to disclosure in notes

10. As per the information and explanations given to us and based on our examination of the books of account and other records, we have not come across material instances in respect of the details mentioned in the Rule 69(6) of Maharashtra Co-operative Societies Rules 1961. 11. We further report that for the year 2020-21 under audit, the Bank has been awarded "D" classification.
