

नवी दिल्ली, दि. २, (प्रतिनिधी) : दिल्लीतील हवा प्रदूषणाच्या मुद्द्यावर देशभरातील पर्यावरण तज्ज्ञांकडून चिंता व्यक्त केली जात आहे. दिल्लीच्या सिमेला लागून असलेल्या पंजाब आणि हरियाणा राज्यांमध्ये खरीप हंगमातील पीक कापणीनंतर पिकांचे अवशेष जाळण्यात येतात. त्याचा प्रदूषण हा दिल्लीला बसत असून, यामुळे शहरातील हवा प्रदूषणामध्ये मोठ्या प्रमाणात वाढ झाली आहे. या सोबतच शहरामध्ये वाहनांची संख्या वाढल्याने देखील प्रदूषणात भर पडली आहे. दिल्लीतील हवा प्रदूषणाला आद्य बसावा यासाठी राज्य सरकारकडून प्रयत्न करण्यात येत असून, दिल्लीचे मुख्यमंत्री अरविंद केजरीवाल यांनी याचा एक भाग म्हणून शहरात सव, विमप पद्धत लागू केली होती. या उपाययोजनांनुसार एका दिवस सम नंबर असलेल्या वाहनांना तर दुसऱ्या दिवशी विमप नंबर असलेल्या वाहनांना दिल्लीमध्ये चालवण्याचे नियोजन करण्यात आले होते. त्याचप्रमाणे शेतातील कचरा न जाळण्याचे आवाहन देखील केजरीवाल यांच्याकडून हरियाणा आणि पंजाबमधून शेतकऱ्यांना करण्यात आले आहे.
