तपासणी, समुपदेशन आणि रक्ताच्या चाचण्याही केल्या जात आहेत. शहरातील काही आरोग्य केंद्रात नुकतीच मॅमोग्राफी तपासणी करण्यात आली. ही तपासणी मुख्यतः स्तनाच्या कर्करोग निदानासाठी केली जाते.
