These financial results have been reviewed and recommended for adoption by the Audit Committee and approved by the Board of Directors at their respective meeting held on 21st May, 2024.

- 2 National Company Law Tribunal (NCLT) vide Order dated 22.12.2023 recorded the payment of Rs.101 Crores by the Company to the Resolution Professional (RP) of Shreem Corporation Limited and accordingly the Company's IA 1002/2022 was disposed. Further NCLT vide order dated 5/4/2024 has directed the Resolution Professional (RP) to pay the said amount to the secured Creditor of Shreem Corporation Limited viz State Bank of India. Giving credence to this development, State Bank of India has informed the appropriate authorities to mitigate action against the Company and is looking to further strengthening banking relationship with the Company.
- 3 The financial result for the quarter and year ended on 31st March, 2024 have been audited by the Statutory Auditors as required under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- 4 The figures for the quarter ending 31st March are the balancing figures between audited figures in respect of the full financial year ended on 31st March and the unaudited published year-to-date figures up to the third quarter of the respective financial years.


