UP govt seeks response on 7 cases against BJP **MLA Som**

AMIL BHATNAGAR NOIDA, AUGUST 13

THE UTTAR Pradesh government has sought the Muzaffarnagar administration's response on seven cases pending against BJP MLA Sangeet Som, a move that comes "usually" before withdrawing cases, according to a senior district official.

These include two cases related to 2013 Muzaffarnagar riots, which had left 62 people dead and more than 60,000 displaced.

A letter has been sent to the Muzaffarnagar administration seeking a response on status quo of the cases filed against Som, the legisfrom lator

Muzaffarnagar Divisional Magistrate Amit Kumar Singh said, "We have received letters from the government regarding certain cases. One of the cases goes back to 2009, and one is from 2013. A response has been sought on 13 points, which is usually done in matters of withdrawal of cases."

He said the government has sought information on court proceedings and witnesses, among other aspects of the case. "The administration and the police will prepare and furnish the report," he said.

Sources said one case relates to circulation of a fake video during the riots, and another involves alleged violation of prohibitory orders on public gatherings.

TN to crack down on schools making students wear caste wristbands

Chennai: The Tamil Nadu School Education Department has asked its officers to identify and crackdown on schools where children were allegedly being made to wear coloured wristbands to identify their caste.

The Director of School Education has directed officials to identify schools in their districts where such discrimination is practised and initiate severe action.

...in some schools in TN, students were made to wear colourcoded wrist bands. These (bands) which come in shades of red, vellow, green and saffron indicate whether they belong to a 'lower' or 'upper" caste'," a circular issued by Director of School Education S Kannappan said. The officer said such practices were supposedly being used for sports team selection, reassembling during class and lunch intervals.

"Allegedly, these practices are enforced by students themselves and supported by influential caste persons and teachers," the circular read.

Jharkhand man kills family, commits suicide

ABHISHEK ANGAD JAMSHEDPUR, AUGUST 13

A 30-YEAR-OLD farmer allegedly murdered his wife and two daughters and then committed suicide in Jharkhand's Garhwa district on Monday.

Police said Shiv Kumar Baitha hung himself from a tree in the village. The bodies of his wife Babita Devi and two daughters aged 6 and 10 were found in a well nearby. Garhwa SP Shivani Tewari said, "The bodies of the wife and the children were found drowned inside the well. One of daughters had injury marks on her neck. We have waiting for post mortem to give us the report. Prima facie the

farmer murdered his wife." The SP said that the reason for

the suicide is not clear. "Family members told us that the farmer remained unwell and had been under treatment...He had also developed insomnia and had not slept for the last month. It seems that it was an act was committed out of depression," she said. Panchayat Satyanarayan Baitha mukhiya said Shivkumar was under stress as he had taken loans from a few people. "He had also taken loans up to Rs 3 lakh. He was constantly stressed about the repayment," he said.

At relief camp in Belagavi college, race against time to vacate campus

KARNATAKA), AUGUST 13

THEIR HOMES reduced to a rubble by the swollen Malaprabha river on the night of August 5, most of the 2,160 displaced people living at the relief camp in Government Junior College, in Belagavi district's Gokak town, are racing against time.

For them, there is little to cheer even as floodwater is receding over the lost two days Belagavi. With Independence Day around the corner, the college officials have received instructions to ask all people at the relief camp to leave by 4 pm Wednesday (August 14).

Officials also want the college to resume from August 16. College principal Arjun Hadimani said: "We have not had classes for 10 days now (due to the flood). Students are suffering. We have done our best (to provided relief); we need to take back the college (now)."

"We have used our midday meal supplies to cook meals (for camp inmates). Now we need to return to providing education,' a senior college official said.

Motilal, 56, whose one-room house has collapsed, said, "We don't know where we will go if the college sends us out tomorrow. We have to rebuild it first before we can return."

According to those at the camp, at least 500 people do not have a house to return to, and the others are concerned about returning to weak structures, where mud and slush have played havoc with the interiors and electrical items.

Kerala: IMD sounds red alert in 2 districts as toll climbs to 92

EXPRESS NEWS SERVICE THIRUVANANTHAPURAM. AUGUST 13

THE IMD on Tuesday sounded a red alert in the Kerala districts of Kozhikode and Malappuram for the next 24 hours even as the toll in the week-long rain rose to 92.

Rescue and relief operations continued at the landslide sites in Malappuram and Wayanad districts, but at least 40 people remained buried in the debris, official sources said.

After the IMD sounded alert for extremely heavy rain in the two districts and heavy rain in six other districts, the state announced a holiday for all educational institutions in these areas.

At Puthumala in Wayanad, where seven people are still missing, Tuesday's search yielded no results. However, at Kavalapara in Malappuram, where 30-odd people are missing, four bodies were retrieved. As many as 59 people were feared dead in Kavalapara, but only 23 bodies have been traced.

According to the state disaster management authority, 59 people are missing across Kerala.

Chief Minister Pinarayi Vijayan conducted an aerial survey of the landslide-affected areas. After visiting relief camps, he said the government was trying to give support and relief to the families of the victims.

Protest about pay, not about food, faith: Zomato founder

EXPRESS NEWS SERVICE KOLKATA, AUGUST 13

ZOMATO FOUNDER Deepinder Goyal, in an internal mail to employees, has said that the protest by a "handful" of food delivery executives in West Bengal's Howrah has nothing to do with "food or religion or beliefs", but is about the recent "rate card correction".

Since August 5, a section of Zomato delivery executives is on strike over the alleged cut in payment rate. On Sunday, their protest grabbed national headlines after the protesting staff alleged the company was forcing them to deliver food items containing beef or pork, which was against their religious beliefs.

"This 'protest', confined to a handful of delivery partners, is limited to the Howrah area... The issue was primarily related to a recent rate card correction in that area, something we routinely do," Goyal wrote.

In his letter, accessed by The Indian Express, Goyal added, "Occasionally, a handful of delivery riders don't understand the rate card corrections and start protesting against the change. In this case in Howrah, instead of constructive engagement with their local Zomato execs (executives), these riders approached a local politician and deliberately framed the issue incorrectly."

There was one order of a food item containing beef but the customer cancelled that order... There is never a moment when anyone outside of the restaurant kitchen is actually coming in contact with any food. So this alleged protest has nothing to do with food or religion or beliefs,' read the letter.

Meanwhile, the delivery executives continued their strike on Tuesday after a meeting with the officials of the company failed to resolve the deadlock.

"Last night, we got a call from the company that a meeting has been organised for Tuesday. A five-member delegation of ours went to attend the meet. Senior police officers were also present. We told the company representative about our payment issue and our unwillingness to deliver pork and beef to customers. He said he can't recommend changes as it is done by senior company officials. One of the senior officials will meet us on August 16," Mohsin Akhtar, one of the protesting executives, told The Indian Express on Tuesday.

However, Zomato didn't issue any communication or comment about the meeting.

EXPRESS NEWS SERVICE JAIPUR, AUGUST 13

FIVE PEOPLE have been arrested in connection with a clash between two communities in Jaipur on Monday night, police said on Tuesday. Police officers said 15 people were injured in the clash and internet services continue to remain suspended in the jurisdiction area of 10 police stations in the wake of the clash.

"An FIR has been registered and we have arrested five people for yesterday night's violence. At present, the situation is peaceful and heavy police deployment has been made in the area," Deputy Commissioner of Police, North, Manoj Kumar told The Indian Express. According to the police, hundreds of people blocked the Delhi highway road near Eidgah

and Galta Gate areas late on Monday night. The mob blocked the road for hours and people from colonies on both sides of the highway started pelting stones at each other, police said.

"The miscreants also set fire to two vehicles and around 15 people were injured in the stone-pelting. Police personnel were also iniured in the clash. We are investigating the cause behind the clash," said Additional Deputy Commissioner of Police Sumit Gupta. He added that preliminary investigation suggests that the clash was not related to the confrontation between Kanwariyas and local residents in Ramganj area on Sunday afternoon.

An uneasy calm prevailed in the area on Tuesday as personnel from several police stations were deployed to maintain the law and order situation.
