
Pursuant to Regulation 30 of the SEBI LODR 2015, we have to further inform you that the operations of the Company's integrated Plant at Sirohi (Rajasthan) and Grinding Units at Jharli (Haryana), Cuttack (Odisha) and Kalol and Surat (Gujarat) have been temporarily closed till further notice as per the directions of the respective State Governments, to contain spread of COVID 19 virus. As directed, operations at our plants based within the States of Rajasthan and Haryana will remain shut up to 31<sup>st</sup> March 2020; Gujarat upto 25<sup>th</sup> March 2020 and Odisha upto 29<sup>th</sup> March 2020.

The situation is dynamic and critical and we are monitoring same very closely. Decision on closure of plant at Durg and other units and the resuming the plant operations generally, will depend on further directions from the respective State Governments.
