- **Subsequent Action Taken by the Exchange:** The Exchange levied fine on the Company amounting Rs. 4,720/-

## Action Taken by the Company and Comments made by the Board:

- 1. The Company has made payment of fine amounting Rs. 4,720/- through NEFT vide Reference No. 000281484467 dated 14/07/2022 to BSE Limited.
- 2. The Company has already complied with the Regulation 24A of the LODR Regulations. Penalty was imposed on revise filing which is not applicable.

The Board of the Company is dedicated towards the compliance of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and always tries their best to keep the Company well compliant as per the provisions notified by SEBI from time to time.
