# RE: CIL NOVA PETROCHEMICALS LIMITED - SCRUTINIZER'S REPORT ON POSTAL BALLOT (E-VOTING) RESULTS

The Board of Directors of CIL NOVA PETROCHEMICALS LIMITED, (hereinafter referred to as "the Company") at their meeting held on July 05, 2023, have appointed me as the Scrutinizer to conduct and scrutinize the Postal Ballot E-voting process in a fair and transparent manner in respect of all the Resolutions as circulated/ stated in the Postal Ballot Notice dated July 05, 2023 ("Notice").

In compliance with the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 read with the General Circular nos. Nos. 14/2020 dated 8th April 2020, 17/2020 dated 13th April 2020, 22/2020 dated 15th June 2020, 33/2020 dated 28th September 2020, 39/2020 dated 31st December 2020, 10/2021 dated 23rd June 2021, Circular No. 20/2021 dated 8th December 2021,

Circular No. 3/2022 dated 5th May, 2022 and 10/2022 dated 28<sup>th</sup> December, 2022 (the "**MCA Circulars**"), and other applicable laws, rules and regulations, to transact the special business as per the postal ballot Notice. The Company had provided facility for remote e-voting to all the Members of the Company to enable them to cast their votes only through electronic means on the items mentioned in the Notice.

The Company has engaged the services of its Registrars and Transfer Agents viz. Link Intime India Private Limited, as the Electronic Voting Service Provider hereinafter referred to as "Link" or "EVSP" or "RTA" who had made necessary arrangements to facilitate E-voting by the shareholders of the Company on their website https://instavote.linkintime.co.in.

Accordingly, the Company sent the Postal Ballot Notice, including all the requisite information required to cast the vote, in electronic form only to all its members who have registered their e-mail addresses with the Company / Registrar & Transfer Agents / Depository Participants. The communication of the assent or dissent of the Members was sought through the E-voting system only.

The Company and the EVSP had uploaded the Notice together with the explanatory statement on their respective websites viz. www.cnpcl.com and https://instavote.linkintime.co.in, Electronic Voting Event Number "230234" was generated for casting the votes through E-voting mode. The Company uploaded the details of the e-voting event with both the depositories viz. NSDL & CDSL. The Company and the EVSP have complied with, all the necessary formalities specified under the Act, the Rules and the Circulars issued in this regard.

The aforesaid Postal Ballot Notice was sent on July 11, 2023, to all the Members of the Company through e-mail who have registered their e-mail addresses as on July 07, 2023 (cut-off date).

The Management of the Company is responsible for ensuring compliance with the requirements of the Act and the Rules there under and SEBI Listing Regulations relating to the items being placed for approval of the members through postal ballot by e- voting. My responsibility as the Scrutinizer of the voting process (through E-voting), was restricted to scrutinize the E-voting process, in a fair and transparent manner and preparing a Scrutinizer's Report of the votes cast in favour and against the resolutions stated in the Notice, based on the reports generated from the E-voting system provided by EVSP.

# The E-voting period commenced at 9.00 a.m. on Friday, July 14, 2023, and ended on Sunday, August 13, 2023, at 5:00 p.m.

In respect of members whose email id's were not available, a Public Notice with regard to the Postal Ballot Notice was published on July 12, 2023 providing requisite information and contact details of the EVSP for registering email IDs and queries on E-voting.

## **Summary of Vote Cast:**
