Kalvan: Due to the election code of conduct, political party leaders turned their backs on buying lanterns in the wake of this year's Diwali festival. For the past 35 years at Bai's Statue Subhash Chandra Bose Chowk in Kalyan West, artisans who have been making decorative items from bamboo for various festivals have been making huge lanterns on the occasion of Diwali as per the demands of political party leaders. These include bamboo ghotivpaper, glossy paper, Also artisan Lakshmi Ganesh Suryavanshi and his family are doing the work of making lanterns from 1 feet to 7 feet from colored cloth. At an average rate of Rs.1000 per foot, lanterns are made with political symbols in the color suggested by the leadership of the political party. There is a huge demand for big lanterns from the leaders of political parties. Mumbai, Thane, Palghar are giving them the job of making lanterns. After Ko Rona, the demand for products made from bamboo has decreased. In the festival of GanapatiNavratri , Christmas, Makhara made from bamboo is in demand, even though the raw material and labor costs have become a little as Makhara environmentally friendly, it is demanded by environmental lovers. But due to inflation consumers are attracted to cheap China made goods. Earlier simple baskets made from bamboo were in great demand. But because of plastic made, these easy, The demand for hats decreased. There was a good demand for ropes made from ghaipat, as well as kathya. However, due to the increasing trend of using plastic and nylon ropes, the artisans have been

affected. Therefore, the artisan class

has suffered as the small businessmen

who make goods from traditional

bamboo are suffering. Despite this, people like Lakshmibai have continued their traditional small-scale industry in the course of time without despairing or getting tired. On this occasion, the administration is trying to emphasize how to get the right market in the innovative plan along with the ongoing plan of the administration for the continuation of traditional small
