New Delhi: Prime Minister Narendra Modi will on Thursday meet top officials of leading sovereign wealth funds and pension funds including British Columbia Investment, Qatar Investment Authority, Temasek, US International Development Finance Corporation, Teachers Retirement Texas, GIC and Japan Post Bank to highlight the industry.

These funds have total assets under management of about \$6 trillion. The funds will have one-to-one interaction with the prime minister post the meeting over next two weeks, economic affairs secretary Tarun Bajaj said. Modi will chair the Virtual Global Investor Roundtable (VGIR) that will also see participation from domestic industry. Tata Group's Ratan Tata, IIL chairman Mukesh Ambani, Sun Pharma founder Dilip Shanghvi, and



Bank of America, BlackRock, and others will also be invited to the meeting. Bajaj will also highlight India's investment opportunities and the present economic situation in India and add that the government would also try to take care
