#### Dear Sir,

- 1) I, Umesh P. Maskeri, Practicing Company Secretary, was appointed as a Scrutinizer by the Board of Directors of De Nora India Limited ("The Company") at its meeting held on February 12, 2020, pursuant to the provisions of Section 110 of the Companies Act, 2013 read with the Rule 22 of the Companies (Management and Administration) Rules, 2014 to scrutinize votes cast electronically i.e. through Remote E-voting as well as through Postal Ballot on the items of business set out in the Notice of Postal Ballot dated February 12, 2020.
- 2) The Company has informed that it has, to its Members, whose names appeared in the Register of Members as on Friday, the February 14, 2020:
  - (i) Completed dispatch on February 19, 2020 of the Postal Ballot Notice and Ballot Form along with postage prepaid business reply envelope;
  - (ii) Sent by electronic mail of Postal Ballot Notice and ballot forms to its Members on February 19, 2020 and who had registered their email ID with the Company/ Depositories.
- 3) In terms of Regulation 47 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014, the Company had duly released an advertisement intimating the voting through Postal Ballot and Remote E-voting and dispatch of Notice, in the following newspapers, which are having wide circulation in the state of Goa:
  - i) English Newspaper viz. Business Standard dated February 21, 2020;
  - ii) in Marathi Newspaper viz. Lokmat dated February 21, 2020.
  - 4. In compliance with the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, the Company had provided Remote E-Voting facility to cast

vote on the resolution through the electronic voting platform of Central Depository Services Limited ("CDSL").

- 5. The postal ballot programme including the remote E-Voting facility remained open during the period from 09-00 A.M. (IST) on Monday, February 24, 2020 to 05:00 P.M. (IST) on Tuesday, the March 24, 2020. During this period, Members of the Company, holding shares in physical and/or in dematerialized form, as on the cut-off date i.e. Friday, February 14, 2020 were entitled to vote on the resolution set out in the Notice of Postal Ballot covered under the EVSN 200213001.
- 6. The e-voting module of Central Depository Services Limited ("CDSL") for the said EVSN was disabled by CDSL on March 24, 2020 at 5.00 P.M. and was unblocked thereafter by me in the presence of 2 witnesses, who are not in the employment of De Nora India Limited.
- 7. The Postal Ballot Forms were kept under my safe custody before commencing the scrutiny of such Postal Ballot forms.
- 8. The Company has informed that Bigshare Services Private Limited, the Registrar and Transfer Agents of the Company, has verified the specimen signatures on the postal ballot forms received from the Members and further that the specimen signatures tallied with the specimen signatures as per the records maintained by the Company/ Registrar and Transfer Agents, except in 4 postal ballot forms.
- 9. The signature of the shareholders differed substantially as compared with the specimen signature recorded with the Company in respect of 4 (Four) postal ballot forms, which accounted for 620 (equity shares) votes, has been rejected and has been found to be invalid.
