We would like to inform you that the Board of Directors of the Company on October 04, 2019 have approved conducting Postal Ballot to obtain approval of the shareholders of the Company by way of Special Resolutions on the following matters:

- i. Divestment of entire investment of the Company in material subsidiaries i.e. Religare Finvest Limited ("RFL") and Religare Housing Development Finance Corporation Limited ("RHDFCL")
- ii. Sale, disposal and leasing of assets exceeding 20% of the assets of Religare Finvest Limited ("RFL"), material subsidiary of the Company.

In this regard, the Postal Ballot Notice shall be dispatched to the shareholders of the Company whose names appear in the Register of Members of the Company as on the Cut-off Date i.e. Friday, October 11, 2019. Dispatch of Notice shall be completed by Thursday, October 17, 2019.

The voting rights of equity shareholders shall be determined based on the equity shares held by them as on Cut-off Date i.e. Friday, October 11, 2019. Furthermore, due to non-payment of dividend by the Company for last two years on 0.01% 2,50,00,000 Non-cumulative Non-convertible Redeemable Preference Shares ("Preference Shares") of face value of Rs. 10/-(Rupees Ten) each, the shareholders holding aforesaid Preference Shares of the Company as on Cut-off Date (i.e. Friday, October 11, 2019) will also be entitled to vote on the resolutions mentioned in the Postal Ballot Notice in proportion to the Preference Shares held by them.
