Launch a free mass vaccination drive across the country: 13 opposition parties ask Centre

New Delhi: Leaders of as many as 13 opposition parties in a joint statement have asked the Central government to launch a free mass vaccination drive across the country in view of the unprecedented surge in COVID-19 cases. The signatories include Congress president Sonia Gandhi, JDS leader and former prime minister HD Deve Gowda, NCP leader Sharad Pawar, Shiv Sena chief Uddhav Thackeray and TMC supremo Mamata Banerjee.

According to the joint statement, "In times of the uncontrollable surge of the pandemic across our country, We call upon the Central government to focus all attention in ensuring the uninterrupted flow of Oxygen supplies to all hospitals and health centres across the country."

"We call upon the Central government to immediately launch a free Mass vaccination programme across the country," it said, adding "The budgetary allocation at Rs 35,000 crore for the vaccination programme must be utilised for this." Notably, the deadly COVID wave claimed a record 3,689 more lives and active cases crossed the 33-lakh mark in India as Haryana and Odisha joined several other states that have been forced to reimpose lockdown or similar curbs in order to check the surge amid a shortage of hospital beds, medicines and oxygen for patients. On Sunday, Prime Minister Narendra Modi reportedly reviewed various measures to augment human resources for effective management of the COVID-19 situation and possible steps discussed include incentivising students and pass-outs of medical and nursing courses to join the pandemic duty.

According to the Union Health Ministry, a total of 86,023 beneficiaries in the age group of 18-44 years received their first dose of COVID vaccine across 11 states on May 1 when phase 3 commenced. The infection count climbed to 1,95,57,457 with 3,92,488 more people being confirmed positive for the disease. States like Tamil Nadu and West Bengal recorded their highest daily rise in cases on Sunday. Meanwhile, the cumulative number of COVID-19 vaccine doses administered in the country has crossed 15.68 crores.

Delhi: Vaccination for 18+ category to begins, 77 schools identified for inoculation exercise

New Delhi: The third and the largest phase of vaccination against Covid-19 began in Delhi on Monday. People in the 18-45 age group are being given jabs against the deadly virus. Around 90 lakh people in this category will be eligible for the jabs. Pre-registration has been made mandatory for beneficiaries in the 18-45 age group and there will be no walk-ins for this category for now.

Five vaccination booths each have been set up at 77 schools for the inoculation exercise. The government has set up vaccination centres at schools to accommodate a high number of beneficiaries. Notably, three big private hospital chains Apollo, Fortis and Max have already started vaccinating people in the 18-45 age group at limited centres from Saturday.

1.34 crore vaccine doses

The Delhi government has placed orders for 1.34 crore vaccine doses with manufacturers which will be delivered over the next three months. Of these, 67 lakh doses of Covishield vaccine are being procured from Pune-based Serum Institute of India. The first tranche of three lakh doses would reach Delhi in the first week of May.

Around 1.5 crore people are targeted to be vaccinated in Delhi, of which 32 lakh have received at least one dose so far. The Delhi government is taking the help of the voters' list to ascertain the number of eligible beneficiaries. According to it, there are around 60 lakh people aged above 45 years. Plan to vaccinate all adults in 3 months

'Launch free mass vaccination drive': Opposition leaders tell Modi govt

New Delhi: Opposition parties have asked the Centre to launch a free mass vaccination drive across the country against Covid-19. A total of 13 parties have jointly issued a statement wherein they urged the Modi government to focus all attention on ensuring uninterrupted flow of oxygen supplies to all hospitals and health centres across the country.

"We call upon the Central government to immediately launch a free mass vaccination programme across the country," the statement said. "The budgetary allocation of Rs 35,000 crore for vaccination programme must be utilised for this," the opposition parties added. The signatories include Congress president Sonia Gandhi, JDS leader and former PM HD Deve Gowda, NCP leader Sharad Pawar, Shiv Sena chief Uddhav Thackeray and TMC supremo Mamata Banerjee. JMM leader and Jharkhand Chief Minister Hemant Soren, DMK chief MK Stalin, BSP supremo Mayawati, National Conference leader Farooq Abdullah, Samajwadi Party chief Akhilesh Yadav and RJD leader Tejashwi Yadav have also signed the statement, besides left leaders D Raja (CPI) and Sitaram Yechury (CPI-M).

Kerala Congress (B) chairman R Balakrishna Pillai passes away

The Brihanmumbai Municipal Corporation (BMC) has announced that the inoculation drive for people above 45 years will remain suspended in Mumbai on Monday due to a vaccine shortage.



Pillai's over six-decade-long political career saw many ups and downs. He had to resign from the ministry for his speech in the 1980s in which he had called for an agitation on the lines of the militancy in Punjab against the central government for ignoring Kerala's development needs. He was the first minister in Kerala who was sentenced to jail for corruption.

Kollam: Kollam Kerala Congress (B) chairman and former minister R Balakrishna Pillai passed away at a private hospital in his hometown Kottarakkara on Monday morning due to age-related ailments, his family said. He was 86. Born in a wealthy family in Kottarakkara, Pillai entered politics during his student days. He was a member of the Students Federation before joining the Congress. He was a member of the AICC from 1958 to 1964. Having been elected to the Assembly in 1960 from the Pathanapuram seat at the age of 25,

Pillai quit the Congress in 1964 and formed the Kerala Congress (B) along with senior leader K M George. Pillai was the founder general secretary of the Kerala Congress (B). He won the election from his home constituency Kottarakkara in 1965, but was defeated in the next two polls in 1967 and 1970. Pillai was elected to the Lok Sabha in 1971 from the Mavelikara constituency. He was a minister for several years in various ministries headed by C Achutha Menon, K Karunakaran, E K Nayanar, and A K Antony.

The Supreme Court had in February 2011 sentenced Pillai and two others to one-year imprisonment for allegedly abusing their positions in the award of a contract for the Idamalayar hydroelectric power project during his tenure as power minister from 1982-1985 in the K Karunakaran ministry. From 2017 onwards, he had been serving as the chairman of the Kerala State Welfare Corporation for Forward Communities, with cabinet rank. Pillai is survived by his three children. His son Ganesh Kumar, who is also a former minister, was re-elected to the Kerala Assembly as an LDF candidate from his family bastion Pathanapuram.
