In terms of Regulation 30 of SEBI (Listing Obligations and Listing Requirements) Regulations, 2015 and SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9th September, 2015, we would like to inform you that, the Company has made an additional investment on rights basis of Rs. 10.5 Crores (Rupees Ten Crore Fifty Lakhs only) in its Wholly Owned Subsidiary, namely Synegra EMS Limited (hereinafter called as "Synegra") on March 17, 2022.

We would also like to inform you that, the Equity Shares of Wholly Owned Subsidiary have been allotted as below:

1,05,00,000 Equity Shares of Rs. 10/- each equalling to 70% of the total paid up capital of Synegra have been allotted to Smartlink Holdings Limited for cash consideration. The total investment stands increased from Rs. 4.5 (Four Crore Fifty Lakhs Only) crores to Rs. 15 crores (Fifteen Crores Only).

The percentage of shareholding of Smartlink Holdings Limited to the total paid up share capital of Synegra pre and post-acquisition remains the same i.e., 100%.
