Quality standard notified for biodegradable disposable utensils

Chennai, July 9: Biodegradable disposal cutlery such as plates made from area leaves, wooden spoons and forks will carry ISI mark denoting their quality. In keeping with the development and growing demand for eco-friendly cutlery, the Bureau of

Indian Standards has recently notified standards for utensils made from agri-by-products.

BIS, Chennai, plans to approach the State government and reach out to self-help groups on manufacturing sustainable alternatives to plastic materials, which meets BIS quality specifications. Officials of the BIS, Chennai, said the Indian

Standard for "Food serving utensils made from agri-by-products-specification" (IS 18267: 2023) was formed to guide the manufacturers on various methods to ensure quality product and help consumers choose quality material with uniform standards across India.

Of late, the number of manufacturers of biodegradable cutlery had increased to match the growing preference for use of eco-friendly material by consumers and food industry. Standards were formulated to streamline the manufacturing of such disposable utensils and assist on testing of the product.

"This is still a voluntary standard that was launched in May. A sticker may be pasted preferably on the bottom of the utensil with various details like the date of manufacture and ISI mark. Hot water and hot oil resistance testing is required," said G. Bhavani, head, Chennai branch office.

GCC to hold camps in 1,415 locations for 'Magalir Urimai Thogai' registrations

Chennai, July 9: Greater Chennai Corporation is likely to start 1,415 camps in the city on July 24 for helping residents register applications for "Kalaignar Magalir Urimai Thogai" scheme.

Under first phase, camps are likely to be held for 10 days. Under the scheme, eligible women aged above 21 will get Rs. 1,000 every month.

According to sources, the camps in Chennai are expected to begin on July 24 and will be

held in two phases. Each phase will be for 10 days. The tokens and applications are expected to be distributed to all ration cardholders at their doorstep 10 days ahead of the camps.

Commissioner J. Radhakrishnan on Saturday conducted the first meeting for implementation of the scheme in Chennai in the presence of officials from other agencies.

"We will go by the government guidelines.

We have identified community halls, schools, and government buildings where people can register for the scheme in a relaxed manner.

We will give separate facilities for helping homeless people register for the scheme," said an official.

The Corporation will make arrangements for drinking water, toilets and facilities for the persons with disabilities at the camps. It has identified buildings for conducting camps based on the number of ration

shops. Tondiarpet zone with the largest number of ration shops will get 156 camps for the scheme. Camps will be held at night shelters to help the homeless people benefit from the scheme. Chennai has more than 10,000 homeless people who do not have adequate records to register for the scheme.

Many are in areas such as George Town. GCC officials will visit such areas to assist homeless people register for the scheme.
