नई दिल्ली, (वीअ)। दिल्ली के रोहिणी में एक स्कूल में चार वर्षीय छात्रा के साथ छेड़छाड़ करने के आरोप में बृहस्पतिवार को स्कूल के चतुर्थ श्रेणी के कर्मचारी को गिरफ्तार कर लिया गया। पुलिस ने यह जानकारी दी। पुलिस के मुताबिक, दक्षिणी रोहिणी पुलिस थाने में बुधवार को दर्ज कराई गई शिकायत में बच्ची की मां ने स्कूल के कर्मचारी पर उसकी बेटी के साथ छेड़छाड़ करने का आरोप लगाया है। पुलिस के एक वरिष्ठ अधिकारी ने बताया कि बच्ची की मां की शिकायत के आधार पर आरोपी व्यक्ति के खिलाफ भारतीय दंड संहिता (आईपीसी) की धारा 354बी और यौन अपराधों से बच्चों के संरक्षण (पॉक्सो) अधिनियम की धारा 10 के तहत मामला दर्ज किया गया। पुलिस अधिकारी ने कहा, हमारे पास केवल एक सुराग था कि आरोपी व्यक्ति की मूंछें थीं। छात्रा का एक मई को ही स्कूल में दाखिला कराया गया था। उन्होंने कहा कि अस्पताल में बच्ची की चिकित्सकीय जांच की गई और बाद में उसकी काउंसलिंग की गई। पुलिस अधिकारी ने कहा, बृहस्पतिवार की सुबह बच्ची द्वारा आरोपी की पहचान किए जाने के बाद सुल्तानपुरी में रहने वाले सुनील कुमार (43) को गिरफ्तार कर लिया गया। वह स्कूल में चतुर्थ श्रेणी के

2020 दिल्ली दंगा मामला : अदालत ने तीन को आगजनी और चोरी के आरोपों से बरी किया

नई दिल्ली, (भाषा)। राष्ट्रीय राजधानी मामले में उनके खिलाफ लगाए गए सभी दिल्ली की एक अदालत ने 2020 में उत्तर पूर्वी दिल्ली में हुये दंगों के दौरान आगजनी और चोरी की वारदात में शामिल तीन लोगों को यह कहते हुए बरी कर दिया कि अभियोजन पक्ष यह साबित करने में भी असमर्थ रहा कि जिन घटनाओं की जांच की

अदालत दिनेश यादव, संदीप और टिंक के खिलाफ मामले की सुनवाई कर रही थी, जिनके खिलाफ उस दंगाई भीड में शामिल होने का आरोप था, जिसने फर्नीचर की एक दुकान में तोडफोड और चोरी की वारदात को अंजाम दिया था। उनके खिलाफ 24 और 25 फरवरी 2020 की रात को भागीरथी विहार में एक सिलाई इकाई को नष्ट करने के लिए आग और विस्फोटक पदार्थ का इस्तेमाल करने का भी आरोप

जा रही है उसके पीछे दंगाई भीड थी।

अतिरिक्त सत्र न्यायाधीश पुलस्त्य प्रमाचला ने बुधवार को अपने फैसले में ैमुझे लगता है कि आरोपियों के खिलाफ लगाए गए आरोप बिल्कुल भी साबित नहीं हुए हैं। इसलिए, आरोपी... इस

आरोपों से बरी किए जाते हैं।

इसके साथ ही न्यायाधीश ने कहा कि अभियोजन पक्ष का यह आरोप है कि ये लोग उस भीड़ का हिस्सा थे, जिन्होंने संपत्तियों को नुकसान पहुंचाया था। उन्होंने कहा कि हालांकि, अभियोजन यह भी साबित नहीं कर सका कि इन घटनाओं के पीछे भीड़ थी, और उस स्थिति में निष्कर्ष यह है कि घटनाओं में अभियुक्तों की संलिप्तता दिखाने के लिए रिकॉर्ड पर कोई साक्ष्य नहीं है।

एएसजे प्रमाचला ने कहा कि इस बात की जबरदस्त संभावना हो सकती है कि दोनों स्थानों पर घटनाएं दंगाई भीड के कारण हुईं लेकिन संभावना सबूत नहीं बन सकती।

न्यायाधीश ने कहा,ै...यह सुनवाई के सबूतों या केवल संभावना के आधार पर अभियोजन पक्ष के अनुमान का मामला बना हुआ है कि इन घटनाओं के पीछे एक भीड़ थीं। उन्होंने कहा कि यह स्पष्ट है कि अनुमान या मजबूत संदेह सबूत का विकल्प नहीं हो सकता है, और इसलिए सबूत के अभाव में यह नहीं माना जा सकता है कि दोनों घटनाओं के पीछे दंगाई भीड़ थी।

आरसी के पैसे की वसूली को बिल्डर की 111 संपत्तियों की नीलामी करेगा उप्र रेरा

नोएडा, (वीअ)। जिला प्रशासन वेव मेगा सिटी सेंटर बिल्डर के कुर्क किए गए 111 फ्लैट और दुकानों की नीलामी करेगा। उत्तर प्रदेश भूसंपदा विनियामक प्राधिकरण (उप्र रेरा) के रिकवरी सर्टिफिकेट (आरसी) का पैसा नहीं देने पर प्रशासन ने बिल्डर की इन संपत्तियों को कुर्क किया है। पहले चरण में 29 मई को 38 फ्लैट और दुकानों को नीलाम कराया जाएगा। यह नीलामी सामान्य नीलामी की तरह से होगी, इसकी ई-नीलामी नहीं की जाएगी। बाकी संपत्ति का मूल्यांकन कराया जा रहा है।

बिल्डर पर यूपी रेरा की आरसी का 123.55 करोड रुपये बकाया है। वहीं, प्रशासन कई अन्य बिल्डरों की संपत्तियों को भी नीलामी कराने की तैयारी कर रहा है।उप-जिलाधिकारी दादरी आलोक गुप्ता ने बताया कि पिछले माह जिला प्रशासन ने 101 बिल्डरो से यूपी रेरा की आरसी का 503 करोड़ रुपये वसूलने का अभियान शुरू किया था। सभी बिल्डरों के घर व कार्यालयों पर मुनादी कराकर 24 घंटे का समय दिया गया था, लेकिन बिल्डरों पर उसका असर नहीं हुआ। इसके बाद प्रशासन ने सख्ती

बरतनी शुरू कर दी है। उन्होंने बताया कि जिला प्रशासन ने वेव मेगा सिटी सेंटर प्राइवेट लिमिटेड के खिलाफ बडी कार्वाई शुरू की है। दादरी तहसील में बिल्डर पर यूपी रेरा की आरसी का 123.55 करोड रुपये बकाया है। बार-बार नोटिस के बाद भी बिल्डर पैसा जमा नहीं कर रहा है। आरसी का पैसा वसलने के लिए प्रशासन बिल्डर की 111 संपत्ति को कुर्क कर चुका है। अब प्रशासन ने कुर्क संपत्ति को नीलाम करने का फैसला लिया है।उन्होंने बताया कि पहले चरण में 38 संपत्तियों को नीलाम कराया जाएगा। इनकी नीलामी 29 मई को होगी। इन 38 संपत्तियों की कीमत करीब 40 करोड़ रुपये है।

नीलामी सफल होने से प्रशासन को बडी धनराशि मिलेगी। उस धनराशि से खरीदारों का पैसा लौटाया जाएगा। बिल्डर की बाकी 73 संपत्ति का सब रजिस्ट्रार से मूल्यांकन कराया जा रहा है।
