With reference to the subject cited, this is to inform the Exchange that production in the Factory is temporary disrupted due to continuing technical issues arising in the machineries and repairs and maintenance activity taken up to fix machine breakdown along with some modifications to improve machine efficiency. Therefore, the factory has been closed from today, i.e., Thursday, the 11th day of August, 2022.

The Company is taking adequate steps to ensure refuctioning of the machineries at the earliest. Until then the factory will remain under closed to carry out the maintenance activity.

During the aforesaid period, the Company will continue to service the key customers uninterruptedly from the inventory of finished goods.

We would keep the stock exchange and all our stakeholders updated on any significant developments going forward and shall also keep informed as soon as the factory becomes operational.
