The voting period for remote e-voting commenced from Friday, July 21, 2023 at 10:00 A.M. (IST) and ended on Monday, July 24, 2023 at 5:00 P.M. (IST) and the CDSL e-voting platform was disabled thereafter.

The Company had also provided remote e-voting facility to the Shareholders present at the AGM through VC/OAVM and who had not cast their vote earlier.
