# Children's Day: Reliance Foundation's annual 'Kahani Kala Khushi' begins; to inspire children across India

Mumbai, Reliance Foundation's Kahani Kala Khushi is back this year's initiative kicked off on Children's Day to inspire children across schools and Anganwadi centres through storytelling and other activities across India over the next few weeks.

The report, titled 'Steady Indian Insurance from Growth to Value in the Upcoming Techade', said that while the country's life insurance industry grew to \$107 billion as of 2023, the general insurance industry touched \$35.2 billion.
