Chinmayanand gets bail in sexual abuse case

¬he Allahabad High Court on Monday granted bail to former Union Minister Swami Chinmayanand, accused of sexually abusing a law student.

Justice Rahul Chaturvedi issued the bail order on the plea filed by the BJP leader.

On November 16, the court had reserved its order after hearing the counsels from both sides.

Chinmayanand, whose trust runs the Shahjahanpur law college where the woman studied, was arrested on September 20 under section 376-C of the IPC, a charge short of rape.



It is applied when someone in authority takes advantage of his official position to 'induce or seduce' a woman to have sex with him. In a parallel case, the woman was charged with trying to extort money from Chinmayanand, whom she had accused of rape.

MINOR SEXUAL ASSAULT CASE -

Special court sentences five accused to life

Chennai: Five of the 15 convicts in the sensational case of sexual assault of a minor child at Avanavaram here were sentenced to life imprisonment by a special court here on Monday.

Pronouncing the quantum of punishment, Judge RN Manjula of the court for trial of cases under POCSO (Protection of Children from Sexual Offences) Act, also sentenced the other 10 convicts to varying terms of imprison-

ment.

Of the five awarded life term, four would remain in prison till death.

Ravikumar (56), Suresh (32), Abhishek (23) and Palani (40) have been sentenced to undergo life imprisonment until death while Rajasekaran (40) has been sentenced to life with entitlement to be released prematurely on his applica-

One of the accused has been sentenced to a seven-year prison term while the other nine have been sentenced to vears Imprisonment. The judge had on Saturday convicted 15 of the convicts and acquitted one. Another died during the course of the trial.

The case relates to the sex-ual assault of a hearingimpaired minor girl by a group of 17 people, mostly plumbers, housekeepers, security guards and lift operators working in an apartment complex at Ayanavaram here. Police had charged the accused with sections 354-B (Assault or use of criminal force to woman with intent to disrobe), 366 (kidnapping), 376-AB, 376-DB, 506 (i) and 506 (ii) of the IPC and sections 5 and 6 of the

Kolkata: The West Bengal Government has provided two thermal scanners to the Netaji Chandra Bose International Airport here to help the authorities conduct surveillance on passengers to contain attack of coronavirus, a senior official said on Monday.

The West Bengal Medical Service Corporation has bought the two thermal scanners at a total cost of ₹ 30 lakhs and handed it over to the city airport authorities on Sunday,

The Kolkata Port authorities have already started using thermal scanners to identify passengers with symptoms of coronavirus, who are arriving at the city using waterways.

Eight passengers, who had travelled in the same flight as that of a coronavirus-affected Kerala resident, had landed at airport on January 23.

पुलिस के लिए कम चुनौती नहीं है गैंगस्टर संदीप काला को पकड़ना

पुलिस टीम पर जानलेवा हमला कर फरार होने वाला कुख्यात बदमाश संदीप उर्फ काला जठेड़ी हरियाणा के कई जिलों में आतंक पर्याय रह चुका हैं। संदीप के खिलाफ डेढ दर्जन से ज्यादा हत्या, हत्या के प्रयास, लूटपाट और रंगदारी वसूलने के मामले दर्ज है। संदीप फिलहाल दो हत्या और हत्या के प्रयास के आरोप में सजा काट रहा था। संदीप जेल में रह कर अपने गिरोह का संचालन कर रहा था। इसी वजह से उसे भौड़सी जेल में शिफ्ट किया गया था। संदीप की गिरफ्तारी के बाद हरियाणा के कई जिलों के लोग राहत महसूस कर रहे थे। अब संदीप के फरार होने से एक बार फिर अपराध जगत में ताबड तोड वारदातें होने का खतरा बड़ गया है। लॉरेंस विश्नोई के राइट हैंड राज बिसोदा को गिरफ्तार कर पुलिस अभी चैन की सांस भी नहीं ले पाई थी कि संदीप पुलिस की गिरफ्त से फरार हो गया। हालांकि पुलिस का दावा है कि संदीप उर्फ काला की गिरफ्तारी के लिए अपराध शाखा और एसटीएफ की टीम लगातार सुराग लगाने का प्रयास कर रही है। उधर गुरूग्राम पुलिस का दावा है कि संदीप वहां नहीं घुस पाया है। ऐसे में पुलिस के लिए संदीप का सुराग लगाना किसी चुनौती से कम नहीं है।
