With reference to the captioned Offer, we wish to inform you that, SEBI vide its Letter No. SEBI/HO/CFD/CFD-RAC-DCR1/P/OW/2024/4718/1 dated February 1, 2024, has issued final observations for the Open Offer for acquisition of shares of the Company from its public shareholders. However, as on date, the anti-trust law approvals from Kuwait and United Arab Emirates ("UAE") required to proceed with the Open offer are pending.
