I, Y. Ravi Prasada Reddy, Practicing Company Secretary having CP number: 5360 and Proprietor of RPR & Associates, Company Secretaries, Hyderabad, was appointed as Scrutinizer by the Board of Directors of M/s. Bartronics India Limited (the Company) for the purpose of scrutinizing the process of postal ballot through remote e-voting on the resolution contained in the Postal Ballot Notice of the Company dated 23rd June, 2023 together with the first corrigendum dated 06th July, 2023 and second corrigendum dated 13th July, 2023.
