# After 8 months at Delhi's border, protesting farmers gather near Parliament

New Delhi. After eight months of harsh winters, unforgiving heat, and rains, farmers protesting against the three contentious agri laws on Thursday reached Jantar Mantar, a few metres away from Parliament where the Monsoon Session is underway, unrelenting in their demand that the legislations be Farmers' representatives from several states, scrapped."We have come this far after losing many of our own. We are ready for a long haul. We have come prepared," said Harpal Singh from Bharatiya Kisan Union (Chaduni), as he wrapped his saffron safa around his head.

The 200 farmers, wearing identification badges and carrying flags of their unions, travelled to Jantar Mantar from their Singhu border The Samyukt Kisan Morcha, a joint forum of protest site in four buses with a police escort. The protest was to start at 11 am, but the farmers reached the venue only by 12.10 pm.Farmer leader Shiv Kumar Kakka said police stopped them at three places en route and their Aadhaar cards were checked. "Even a bus from Pakistan won't be subject to such strict checking The government wants to harass the farmers," Harpal Singh said."Two of our buses broke down en route, so police escorted us in DTC buses," he added. Upon

reaching Jantar Mantar, the farmers raised slogans, pumping their fists in the air, and demanded that the government scrap the three laws. However, they were restricted to a small section of Jantar Mantar with police putting up barricades on both sides.

including Maharashtra, Odisha, Kerala, West Bengal, Telangana, Gujarat, Punjab, Haryana, and Uttar Pradesh, joined the stir. They organised a "Farmers' Parliament" and debated the changes in the APMC Act in two sessions, punctuated by a 'langar (community kitchen), on the first day. The debate also featured women and the elderly.

the farmers' unions protesting against the three laws, said 20 MPs from Kerala visited the farmers' parliament and expressed solidarity with them.As no politician was allowed to share the stage, the MPs joined in as audience.Farmer leaders say 200 farmers will come to the protest site everyday till August 13 to discuss the three laws clause by clause. Police threw a ring of security around central Delhi and kept a tight vigil on the movement of vehicles. Several teams of the



Delhi Police manned the roads leading to the protest venue, while personnel of the Rapid Action Force, a specialised unit of the Central Reserve Police Force, stood guard at the site, carrying riot shields and batons.

This is the first time since the violence in the national capital during a tractor rally on January 26 that the authorities have granted permission to the protesting farmer unions to hold a demonstration in the city.Gathering for protests is currently not allowed in the national capital in view of the Covid-19 pandemic, according to an order by the Delhi Disaster Management Authority.

Thousands of farmers from across the country have been agitating at three Delhi border points -- Singhu, Tikri and Ghazipur -against the three farm laws that they claim will do away with the minimum support price system, leaving them at the mercy of big corporations. Over 10 rounds of talks with the government, which has been projecting the laws at major agricultural reforms, have failed to break the deadlock between the two

## Jammu and Kashmir Police shoots down drone in Akhnoor, recovers 5 kg IED

New Delhi. The Jammu and Kashmir Police on Friday shot down a hexacopter drone in Akhnor area of Jammu district. The drone was shot down around 8 kminside the International Border (IB), Police also recovered 5 kg of improvised explosive device (IED) which was to be assembled and to be used by terrorists, police said. Agencies are probing whether terror outfit Lashkar-e-Taiba (LeT) is behind the drone activity and using this modus operandi for a terror attack as in previous cases. This is not the first time a drone was spotted in Jammu or near the International Borders. Since the twin blasts at the Jammu airbase on June 27, several drones were spotted in the last one month on multiple locations in Jammu, raising threat of a drone attack. Amid the heightened drone activity, Jammu and Kashmir DGP Dilbag Singh recently directed officers to remain extra alert as terror outfits are continuously trying to use drones for terrorist activities. "Terror outfits are continuously attempting to use New Delhi. The Jammu and Kashmir Police outfits are continuously attempting to use drones for terrorist activities," DGP Dilbag Singh was quoted by news agency PTI as saying.

## Covishield to only be used for administering second doses till July 31 in Delhi

New Delhi. Delhi had less than a day's stock of coronavirus vaccine left on Thursday morning, prompting the government to issue an order stating that Covishield will only be used for administering second doses till July

A total of 48,256 vaccine doses were administered here on Thursday, taking the total number of doses given so far in the national capital to 95,66,720, of which, 23,14,539 are second doses, according to the data available on Co-WIN portal.

The city had 65,460 doses of Covishield left on
Thursday morning, it said. A total of 63,406
vaccine doses were administered in Delhi on
Wednesday. Of these, 33,443 were second
doses, the bulletin said.Delhi had received
70,000 doses of Covaxin on Wednesday,
taking the total number of available doses to
2,45,590.Only 20 per cent of Covaxin stocks
can be used for the first dose since these

On account of limited stocks of Covishield, the city government has directed that the stocks be only used for second dose till July 31, at all its centres;" the bulletin said, adding that many in the 18-44 age group will be qualifying for the second dose in the coming weeks. A total of 55,01,302 men and 40,63,333 women have been inoculated against the novel coronavirus infection in the national capital, according to the Co-WIN portal.

portal, ss many as 46,38,201 people in the 18-44 age group have received at least one dose of the vaccine, while 30,64,552 lakh people in the 45-60 age group have been inoculated. More than 18,63,967 lakh people above 60 years have been vaccinated, the bulletin added.


