Hyderabad: Rebuking both police and judges of trial courts, the Telangana high court on Thursday directed the state's police brass to explain by Monday why they did not follow the Supreme Court-mandated procedure while arresting Telangana Praja Front (TPF) vice-president N Krishna and Telangana Vidyarthi Vedika (TVV) president Bandari Shankareappa Maddileti, a student of Telugu University, from TPF office at Baghlingampally on Tuesday.

the family members or a leader while arresting and taking away a person from his residence. A bench of Chief Justice Raghavendra Singh Chauhan and Justice A Abhishek Reddy, which was hearing a habeas corpus plea filed by wives of the two detainees, gave the direction after noticing certain

discrepancies in the procedure followed by police. The bench had earlier summoned the record pertaining to the arrest and also directed police to produce the duo before court.

On Thursday, the bench went through the arrest record and pointed out that police did not follow the procedure contemplated under Section 41B of the CrPC. "There is no proof here that you have informed the family members of the arrested persons. Nor is there any signature of a local responsible person. The arrest memo did not contain these essential details. This makes the arrest illegal," the bench observed.
