# सौर प्रणाली से एक करोड़ परिवारों को मिलेगी 300 यूनिट मुफ्त बिजली

जनसत्ता ब्यूरो नई दिल्ली, 1 फरवरी।

वित्त मंत्री निर्मला सीतारमण ने लोकसभा में अंतरिम बजट 2024-25 पेश करते हुए हरित विकास और अक्षय ऊर्जा को बढ़ावा देने के लिए उपायों की घोषणा की। इसके तहत छत पर सौर प्रणाली लगाने से एक करोड़ परिवार हर महीने 300 युनिट तक निशुल्क बिजली प्राप्त मिल सकेगी। यह योजना, अयोध्या में राम मंदिर में प्राण प्रतिष्ठा के एतिहासिक मौके पर प्रधानमंत्री के लिए गए संकल्प के अनुसरण में लाई गई है।
