The voting period for remote e-voting commenced on at 9.00 a.m. (IST) on Monday, 13<sup>th</sup> June 2022 and ends at 5.00 p.m. (IST) on Tuesday, 12<sup>th</sup> July 2022. The e-voting module was disabled by LIIPL thereafter.

The votes cast under remote e-voting facility were thereafter unblocked.
