Press Release

Update on Arbitration Award

The Learned Arbitral Tribunal had passed an award dated 22.11.2022 in favour of the Company against Public Works Department, Delhi for a residential complex project in Delhi for a sum of Rs 9.29 crores plus interest at the rate of 10% p.a. payable from the date of publication of award i.e. 22.11.2022.

The Hon'ble High Court of Delhi in the Execution Petition filed by the Company has directed Public Works Department, Delhi to deposit the entire arbitration award amount along with upto date interest with the Registrar General of High Court of Delhi. The Company had filed Execution Petition for Rs 9,68,86,475/- including interest upto 24.04.2023 and future interest @10% p.a.

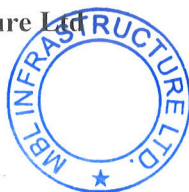
