b) As a part of the above, the Company had made a provision of ₹ 263.13 lakhs for onerous contracts. During the quarter ended December 31, 2022, the Group served a notice of termination to the Ministry of Information Affairs (MOIA), Government of Bahrain expressing its inability to continue services in the region due to continued losses and high license fees. The Group is currently awaiting a formal revert from the MOIA. Post serving the afforementioned notics and subject to the outcome of ongoing discussions with the MOIA, the operations in the Kingdom of Bahrain continues to be disclosed as discontinuing operations in the results included for all the periods presented
